



## Voltaia commissions its largest solar plant

**Voltaia (Euronext Paris, ISIN code: FR0011995588), an international player in renewable energy, announces that it has completed the full commissioning of SSM1&2. Located in the Serra Branca cluster in the Brazilian state of Rio Grande do Norte, it is now Voltaia's largest solar project in the world with a capacity of 320 megawatts.**

*"The commissioning of SSM1-2 is a great achievement. I would like to warmly thank all the Voltaia teams, as well as the suppliers and subcontractors, who have been working together on this 320 megawatt photovoltaic project. Their work continues with the adjacent 260 megawatt SSM3-6 project, which began in March 2022,"* said Sébastien Clerc, CEO of Voltaia.

The construction of the 320 megawatt SSM1-2 solar plant is finishing its final completion tests with its final works. Construction was launched in September 2021. Commissioning was progressive, with the gradual installation of solar panels and infrastructure, first production in April 2022<sup>1</sup>, a crossing point of 245 megawatts at the end of June and almost 320 megawatts today.

Initially with a capacity of 32 megawatts, the size of the project has been increased tenfold thanks to new long-term power sales contracts signed with a series of buyers, including Braskem, a large petrochemical group, and Copel, one of leaders of the Brazilian electricity sector and partner of Voltaia in several operations. The long-term power sales contracts have an average duration of 16 years.

The STOA investment fund has held 33% of the SSM1-2 plant since March 2022<sup>2</sup>.
